Update December 15, 2020

North Little Rock, Arkansas (December 15, 2020) – On December 14, 2020, Detectives of the NLRPD arrested the second suspect in this homicide investigation. Kenneth L. Connors, 59, of Jacksonville, Arkansas was arrested on his warrant for capital murder for his involvement in the April 21, 2020 deaths of Derrick Allen and Darrell Momphrey. Kenneth L. Connors has also been charged with Possession of a Firearm by Certain Persons and Tampering with Evidence.

Kenneth L. Connors is scheduled to appear in the NLR District Court on December 15, 2020.

Update November 6, 2020

North Little Rock, Arkansas (November 6, 2020) – On November 5, 2020, NLRPD Officers arrested Brian Allen, 42 years old, of North Little Rock. Brian Allen has been charged with two counts of Capital Murder for his involvement in the April 21, 2020 deaths of Derrick Allen and Darrell Momphrey. Brian Allen has also been charged with Possession of a Firearm by Certain Persons and Tampering with Evidence.

NLRPD Detectives have also obtained a Capital Murder Warrant for Kenneth Lavern Connors for his involvement in this incident. Connors, who resides in Jacksonville, has not been located at this time. Update August 6, 2020

North Little Rock, Arkansas (August 6, 2020) – NLRPD Detectives have released the names of the victims. They are Darrell Momphrey, 57 years old of North Little Rock, Arkansas and Derrick Allen, 40 years old of North Little Rock, Arkansas. Detectives also advised that are investigating each victim's death as a homicide.

LRPD Homicide Investigation Turned Over to North Little Rock Police Department

North Little Rock, Arkansas (April 29, 2020) – On April 21, 2020 at approximately 4:43 am, Officers of the Little Rock Police Department (LRPD) responded to a suspicious vehicle behind 3304 Broadway Street in Little Rock, Arkansas. Upon Officers arrival, they located a white Ford Explorer. Inside the vehicle, Officers discovered two adult black males who were deceased.

LRPD Homicide Detectives responded to the scene and initiated an investigation. That investigation led LRPD Detectives to a residence located at 2905 E. Broadway in North Little Rock, Arkansas. It was at that time that it

was determined that the primary investigation would be turned over to the North Little Rock Police Department Investigations Division (NLRPD).
